## **Legal Basis**

Where we process your personal data using cookies, the processing is justified by an adequate legal basis. Depending on which cookie we use, this legal basis is

- a) our legitimate interests to process personal data in connection with cookies that are necessary for the performance and functions of the website;
- b) the performance of a contract with you where it is necessary to process your personal data in connection with the services we offer on our website;
- c) your consent to the processing of personal data in connection with cookies that are used for tracking and profiling.

# Withdraw Your Consent at Any Time

If you do not wish to accept cookies in connection with your use of the website, you will need to delete, and block or disable cookies via your browser settings; alternatively, you can opt-out on our Cookie List. See below for more information on how to do this. Please note that disabling cookies will affect the functionality of the website, and may prevent you from being able to access certain features on the website.

#### What Is a Cookie?

A cookie is a small file of letters and numbers that we store on your browser or the hard drive of the device you use when visiting our websites. Unless you have adjusted your browser setting so that it will block cookies, our system will issue cookies on your browser as soon as you visit the websites.

# **Key Concepts**

There are different types of cookies with different functionalities that are commonly used:

## First and third-party cookies

Whether a cookie is 'first' or 'third' party refers to the domain placing the cookie.

- *First-party cookies* are those set by a website that is being visited by the user at the time (e.g., cookies placed by our website domain, for example www.fmc.com).
- Third-party cookies are cookies that are set by a domain other than that of the website being visited by the user. If a user visits a website and another entity sets a cookie through that website, this would be a third-party cookie.

Persistent cookies: These cookies remain on a user's device for the period of time specified in the cookie. They are activated each time that the user visits the website that created that particular cookie.

#### Session cookies

These cookies allow website operators to link the actions of a user during a browser session. A browser session starts when a user opens the browser window and finishes when they close the browser window. Session cookies are created temporarily. Once you close the browser, all session cookies are deleted.

## How to Delete and Block our Cookies

Most web browsers allow some control of most cookies through the browser settings. However, if you use your browser settings to block all cookies (including essential cookies), you may not be able to access all or parts of the website. Unless you have adjusted your browser setting so that it will refuse cookies, our system will issue cookies as soon as you visit the website.

#### **Changing your Cookie Settings**

The browser settings for changing your cookies settings are usually found in the 'options' or 'preferences' menu of your internet browser. In order to understand these settings, the

#### What Cookies Do We Use and Why?

Generally the website uses cookies to distinguish you from other users of the website. This helps us to provide you with a good experience when you browse the website and also allows us to improve it.

The cookies we may use on the website may be categorized as follows:

- Strictly necessary
- Performance
- Functionality
- Targeting

Some cookies may fulfill more than one of these purposes.

'Strictly Necessary' cookies let you move around the website and use essential features like secure areas. Without these cookies, we cannot provide the requested services. The strictly necessary cookies are identified as such in our Cookie List. The legal basis for the use of these cookies is either the performance of a contract or our legitimate interests, which are listed below:

- Identify you as being logged in to the website and to authenticate you
- Make sure you connect to the right service on the website when we make any changes to the way it works
- For security purposes
- Make sure you connect to the right service on the website when we make any changes to the way it works

Accepting these cookies is a condition of using the website, so if you prevent these cookies we can't guarantee how the website or the security on the website will perform during your visit.



Your personal data which is processed by using the strictly necessary cookies are stored until you delete the cookies or after a specific time period after you first accepted the cookie. Details can be found on page 6/7 in Table 1.

'Performance' cookies collect information about how you use the website e.g. which pages you visit, and if you experience any errors. These cookies do not collect any information that could identify you and are only used to help us improve how the website works, understand the interests of our users and measure the effectiveness of our advertising.

We use performance cookies to:

- Carry out web analytics: Provide statistics on how the website is used
- Perform affiliate tracking: Provide feedback to affiliated entities that one of our visitors also visited their site
- Obtain data on the number of users of the website that have viewed a product or service
- Help us improve the website by measuring any errors that occur
- Test different designs for the website

Some of our performance cookies are managed for us by third parties.

'Functionality' cookies are used to provide services or to remember settings to improve your visit. The strictly functionality cookies are identified as such in our Cookie List. The legal basis for the use of these cookies is either the performance of a contract or our legitimate interests, which are listed below:

We use 'Functionality' cookies for such purposes as:

- Remember settings you've applied such as layout, text size, preferences and colors
- Remember if we've already asked you if you want to fill in a survey
- Remember if you have engaged with a particular component or list on the website so that it won't repeat
- Show you when you're logged in to the website
- To provide and show embedded video content Some of these cookies are managed for us by third parties

Your personal data which is processed by using the functionality cookies are stored until you delete the cookies or after a specific time period after you first accepted the cookie. Details can be found on page 6/7 in Table 1.

'Targeting' cookies are used to track your visit to the website, as well other websites, apps and online services, including the pages you have visited and the links you have followed, which allows us to display targeted ads to you on the website. The legal basis for the use of our targeting cookies is your consent.



We may use targeting cookies to:

- Display targeted ads within the website.
- To improve how we deliver personalized ads and content, and to measure the success of ad campaigns on the website.

Your personal data which is processed by using the targeting cookies are stored until you delete the cookies or after a specific time period after you first accepted the cookie. Details can be found on page 6/7 in Table 1.

## **Analytics**

#### Anonymization / Truncation in the EEA

Google Analytics is a web analytics service provided by Google, Inc. ("Google"). Google uses cookies to help us analyze how users use the website. In case of activation of the IP anonymization, Google will truncate/anonymize the last octet of the IP address for Member States of the European Union as well as for other parties to the Agreement on the European Economic Area. On behalf of the website, Google will use this information for the purpose of evaluating your use of the
